14.5.1 : Entry fees shall be considered late if received at the PBA office after the seven (7) day deadline date (March 22, 2009) but prior to the official start date of the tournament (March 29, 2010). The late fee is \$50.

14.6.1(b) Any competitor whose entry fee is received on-site at a PBA Tour event after the entry fee deadline date (7) days prior to the tournament start will be charged a \$50 late fee.

14.6.1(c) Any competitor whose entry fee is received on-site at a PBA event on or after the start date of the tournament must pay an additional fee of \$100.

*There will be a \$25 late fee for paying TQR entry fees on-site.

*Late fee rules 14.5.1 and 14.6.1 are in effect for all open tournaments.
